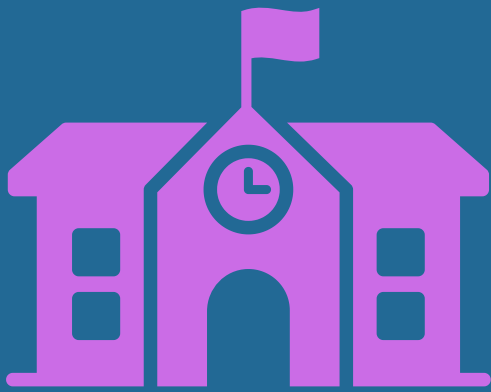

# HISTORY OF THE ACT

McKinney-Vento (MKV) is a federal law that was passed in 1987.

The law has since been amended with greater focus on K-12 students experiencing housing insecurity.

This act is meant to help remove any barriers that a child, youth, or young adult that is experiencing homelessness may have.

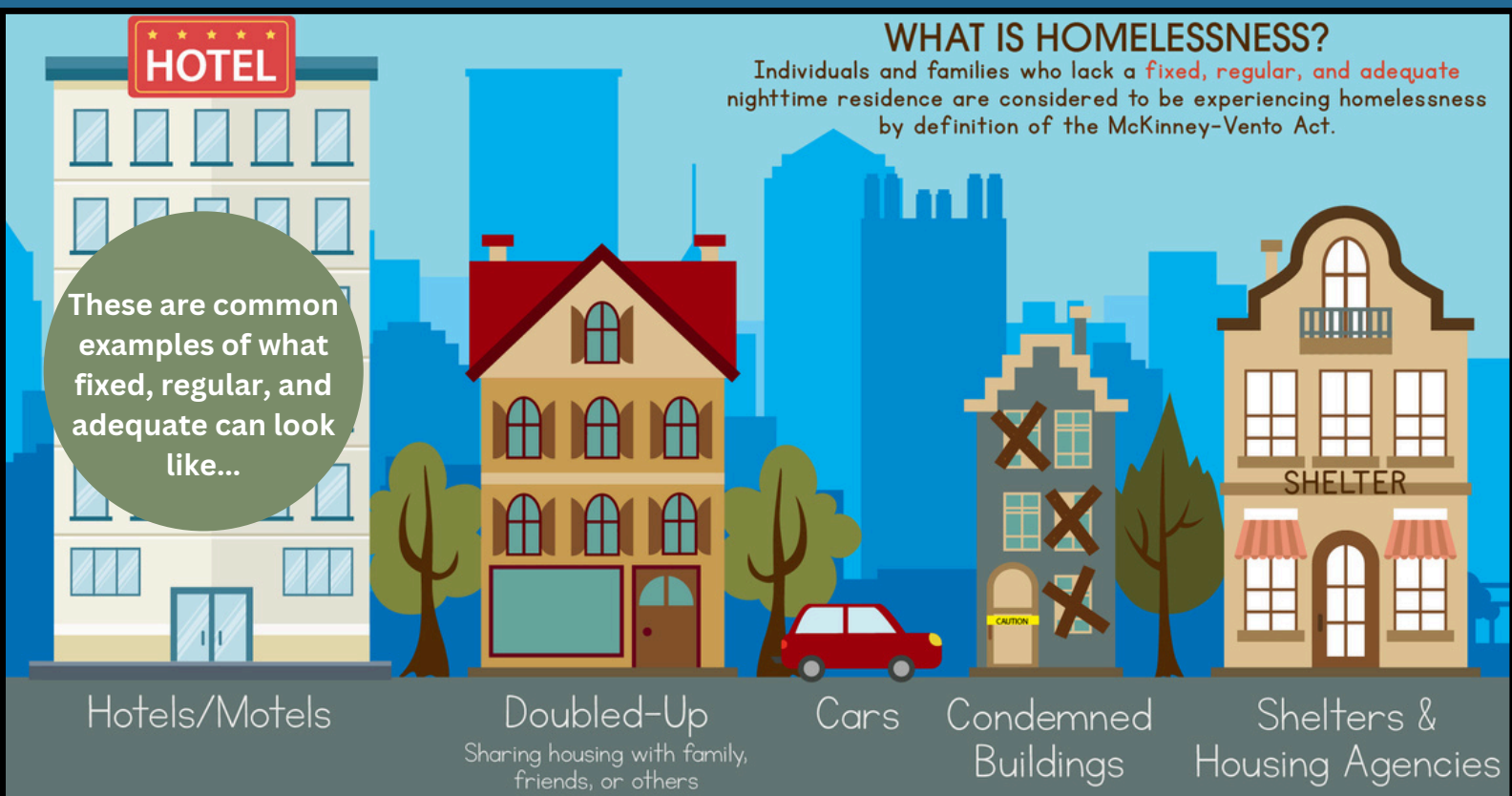

# WHAT YOUTH HOMELESSNESS MEANS ACCORDING TO THE ACT



## FIXED

A **fixed** residence is stationary, permanent, and doesn't change.

## REGULAR

A **regular** residence is one that is used on a regular basis (i.e. nightly).

## ADEQUATE

An **adequate** residence is one that is sufficient for meeting both the physical and psychological needs of an individual.

# How MKV can support your students!

## Immediate SCHOOL enrollment!

With or without parent signatures. Even if paperwork is delayed or late



## Transportation!

To and from the school of origin (school that student was last enrolled in) even if they're presently living outside of the district

## Paid for School activities!

**This can include:**

School supplies, clothing, lunch, additional school and sport fees, extracurricular activities, etc.

# WHAT MIGHT YOUTH HOMELESSNESS LOOK LIKE?

*You know your students best. If you're uncertain here are some common signs:*



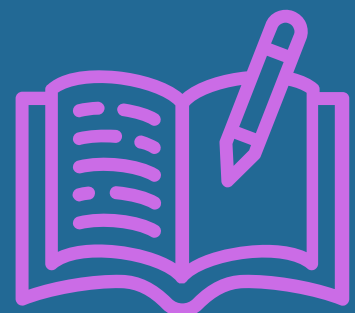
Taking extra portions of food, wearing the same or unclean clothing

Difficulties with transportation, attendance, and paying fees for field trips or sports



Housing that is frequently changing and unstable, or staying with another family or friend.

Consistently turning assignments in late or not at all
